NOTIFICATION

Subject: Declaration of the Results of the Third Parliamentary Elections 2018: Primary Round of the National Assembly

The Election Commission of Bhutan has the honour, under Section 442 of the Election Act of the Kingdom of Bhutan 2008, to hereby declare the results of the Primary Round of Elections to the National Assembly 2018 with the Poll Day on 15th of September 2018.

The total votes received by the four contesting Political Parties are as follows:

The Overall Voter Turnout was **66.36** % with a total of **291,098** voters having cast their votes out of the total of **438,663** Registered Voters. Of the total votes cast, **182,518** votes were cast in person on the Electronic Voting Machines in the **865** polling stations and **108,580** votes through Postal Ballots.

The Druk Nyamrup Tshogpa, secured a total of **92,722** votes which is the *highest* number of valid votes received by a Party and the Druk Phuensum Tshogpa, secured a total of **90,020** Votes, the *second highest* number of valid votes received.

Accordingly, the Election Commission invites the **Druk Nyamrup Tshogpa** and **Druk Phuensum Tshogpa** to formally nominate one Candidate each to contest the General Elections in the 47 National Assembly *Demkhongs* as per the Laws.

Bhutan Kuen-Nyam Party, Druk Nyamrup Tshogpa, Druk Phuensum Tshogpa and People's Democratic Party must file the Returns of Election Expenses of the Primary Round to the concerned Dzongkhag Electoral Office or directly to the Public Election Fund Division within thirty days of declaration of the Results of Primary Round of election i.e. by 16th of October 2018 in the prescribed Form (**Public Election Fund Form No. 7D**).

The **Druk Nyamrup Tshogpa** and **Druk Phuensum Tshogpa**, contesting the General Election shall continue to report and submit weekly Election Expenses verified by respective Observers. The campaign fund for General Election shall be released as per schedule only upon fulfillment of the weekly reporting requirement. These two parties and candidates shall thereafter file the Election Returns separately for the Primary Round and General Election, as required under the laws, within 30 days of the declaration of General Election Results i.e. by 19th of November 2018.
