**Subject: Declaration of the Results of Bye-Election to *Nanong\_Shumar*  
*Demkhong* of Pema Gatshel Dzongkhag, 2013**

The Election Commission of Bhutan under Section 457 of the Election Act of the Kingdom of Bhutan, 2008, hereby notifies the general public that **Dechen Zangmo** of **Druk Phuensum Tshogpa** Party has been elected as the Representative from *Nanong\_Shumar National Assembly Demkhong* under Pema Gatshel Dzongkhag at the Polls held on 9<sup>th</sup> of November 2013.

The Overall Voter Turnout was **35.2%** with a total of **2,913** Voters, out of the total of **8,278** Registered Voters casting their votes. Of the total votes cast, **2,632** votes were cast in person on the Electronic Voting Machines in the 17 polling stations and **281** votes through Postal Ballots. 
