## **Press Release**

The Election Commission of Bhutan is pleased to inform the general public that the four registered Political Parties submitted their Letter of Intent within the timeframe issued in the Election Schedule notified to the public on 18<sup>th</sup> of August 2018.

Druk Nyamrup Tshogpa submitted the *Letter of Intent* on 18<sup>th</sup>, Bhutan Kuen-Nyam Party on 19<sup>th</sup> and the People's Democratic Party and Druk Phuensum Tshogpa on 21<sup>st</sup> of August 2018.

The *Letter of Intent* (LoI) documents include Tentative List of 47 Candidates, Income & Expenditure Statement of Last Financial Year (FY 2016-2017) and till filing (July to mid-August 2018), List of 20 Dzongkhag Party Offices and contact details, Membership Lists, Social Media Links of Party office and Candidates and the Party Manifesto.

The process of the scrutiny and decision was carried out as per the *Procedure* in *Guidelines for Scrutiny of the Books of Accounts of the Registered Political Parties 2018* and opportunity provided to all Parties to submit revisions and clarifications as observed and found necessary under the Electoral Laws.
