## NOTIFICATION

# Bye-Election for National Assembly Member of Khamdang\_Ramjar \*Demkhong\* of Trashi Yangtse Dzongkhag

The Election Commission of Bhutan, in pursuance of Sections 577 and 579 of the Election Act of the Kingdom of Bhutan 2008, hereby issues this notification for Bye-Election to Khamdang\_Ramjar National Assembly *Demkhong* under Trashi Yangtse Dzongkhag.

The Election Schedule and the details concerning the Nomination of Candidates, Electoral Roll, EVMs, Polling Officials, Polling Management, Security and other arrangements are hereby being notified as follows:

#### (A) Election Schedule

1. The schedule of dates and time for the bye-election shall be as follows:

## (B) Filing of Nomination Papers by Candidates

- 2. The nomination papers shall be submitted by a candidate nominated to contest the bye-election with the last date for filing nominations on 8<sup>th</sup> January, 2022.
- 3. The nomination papers must be complete, signed and countersigned as required and include the following prescribed forms:
  - 3.1. Notice of Nomination of a Candidate;

- 3.2. Nomination form;
- 3.3. Asset declaration attested jointly by ACC and ECB;
- 3.4. Tax Clearance Certificate;
- 3.5. Audit Clearance Certificate for Election;
- 3.6. Security Clearance Certificate for Election;
- 3.7. Formal University Degree attested by ECB based on the endorsement of qualification by the BAC;
- 3.8. Relieving order from concerned agencies (if relevant);
- 3.9. Marriage certificate, if applicable;
- 3.10. Office of Profit Form;
- 3.11. VPIC/CID of the candidate (to be produced in original at the time of filing of nomination);
- 3.12. VPIC/CID copy of spouse, if applicable; and
- 3.13. Court Affidavit
- 4. A candidate eligible to contest the bye-election shall be a registered member of the ruling or opposition party provided under Section 209 (b) of the Election Act of the Kingdom of Bhutan, 2008.

#### (C) Scrutiny of Nominations

- 5. The Returning Officer shall undertake the scrutiny of the nomination papers filed by the candidates.
- (**D**) The candidates contesting bye-election should get their Asset Declaration attested by the Department of Election before filing nominations to the concerned Returning Officer.

#### (E) Last Date for Withdrawal of Candidature

6. The last date for withdrawal of candidature shall be 4 p.m. on 11<sup>th</sup> January, 2022 as per Section 225 of the Election Act of the Kingdom of Bhutan, 2008.

#### (F) Demkhong

7. The details of the *demkhong* in which the bye-election has been called is as follows:

#### (G) Electoral Roll

- 8. The qualifying date shall, in relation to the Electoral Roll for the byeelection to Khamdang\_Ramjar National Assembly Demkhongs, be on 1<sup>st</sup> October, 2021. Therefore, any person who attains the age of eighteen years as on 1<sup>st</sup> October, 2021 shall be deemed to meet the minimum age requirement as a voter under the Electoral Laws.
- 9. A registered voter who is born on or after 8<sup>th</sup> January 1957 and before 8<sup>th</sup> January 1997 shall be deemed to meet the maximum (65 years) and minimum (25 years) age requirement for nomination as a candidate for the bye- election.

#### (H) Election Code of Conduct

- 10. The Election Code of Conduct shall come into force from the date of the notification calling for the bye-election and shall continue to be in force until the completion of the election period i.e., 29<sup>th</sup> December, 2021 to 4<sup>th</sup> February, 2022.
- 11.All election officers, political parties, candidates and voters must comply with the Election Code of Conduct and the provisions of the Electoral Laws, Rules and Regulations and Guidelines.

#### 12. Election Campaign

- 13. The campaign period for the bye-election shall commence from 11<sup>th</sup> January, 2022 onwards and must end at 8 a.m. of 1<sup>st</sup> February, 2022 i.e., 48 hours before the commencement of poll on the poll day.
- 14.A candidate shall campaign strictly as per the campaign schedule approved by the Returning Officer and a copy endorsed to the National Observer.
- 15.No travels, public gatherings or official tours shall be undertaken by any Member of Parliament or Party officials to the *Demkhong* during election period except for a purpose that cannot wait under the Laws but only with prior approval of the Returning Officer.
- 16. All those under the laws not eligible to campaign for or against a candidate or a party in an election, including all elected position holders in the Local Government, shall ensure that they do not engage directly or indirectly in the election campaigns.
- 17. The campaign schedule shall be intimated to the voters through mass media and notice on the election advertising boards. In so doing, it must be ensured that no coercion or deterrence is exercised to compel or prevent attendance at such events.
- 18.No candidate shall use the title, designation, rank, *Kabney/Rachu*, *Pata/Geyntag*, or any other sign, insignia or symbol of an office held earlier, on person, car or any personal effects as may be used during the campaign period by the candidate, representatives or supporters.
- 19.A civil servant, except in the capacity of an election official mandated to fulfil a required electoral function, should not attend campaign meetings

- 20.All banks or financial institutions shall report to the ECB of any abnormal transaction of money, including in the account of a candidate contesting the bye-election in the respective *demkhong*.
- 21.A door-to-door election campaign shall not be conducted before 6 a.m. and after 6 p.m.
- 22. Any unauthorized person carrying out election campaign activities must be reported to an election officer or election security personnel on duty to be prosecuted for violation of Electoral Laws.
- 23.A candidate shall be liable for all acts of commission and omission of their election representatives and *Godenpas/Layjepas/Jabchorpas* which may include any interference in the conduct of lawful electoral works and/or disturbing peace and order, undermining free and fair election.
- 24.A party or a candidate during the bye-election shall carry out all election campaign activities only upon obtaining permit from the Returning Officer.
- 25.A party worker or supporters appointed by a candidate or a party to carry out election campaign activity must bear in person two identity cards; one issued by his/her Party and the other by the Returning Officer.
- 26.A candidate, party and all concerned shall neither serve meals and refreshments nor pay money give gifts and reward the general public or voters for attendance of election campaigns or produce, wear and distribute T-shirts and caps for campaigning.

### (I) Election Campaign Finance

27.A candidate shall, upon acceptance of his/her nomination by the Returning Officer, be eligible to receive Election Campaign Fund at the rate of Nu. 150,000/-.

28.A candidate cannot exceed his/her election campaign expenses beyond the ceiling fixed by the Election Commission i.e., total of Nu. 150,000/- being provided by the State and up to an equivalent amount being permitted to be spent from the party's resources, raised from the permissible sources.

#### **Election Campaign Returns**

29.A candidate must submit weekly accounts of campaign expenses and file Election Returns as per the prescribed procedures set out in the Public Election Fund Rules and Regulations of the Kingdom of Bhutan, 2018.

#### **Public Debate**

30. Public debates shall be arranged and conducted in collaboration with the BBSC TV as per the Guidelines for Conduct of Public Debates for the Bye-Election of Khamdang\_Ramjar National Assembly *Demkhong*.

#### (J) Remaining Above Politics and Apolitical

- 31.No religious events, involving public gathering, shall be organized or conducted during the election period.
- 32.Religious personalities shall neither vote in the election nor participate directly or indirectly in the election.

#### **Civil Society Organisations (CSOs)**

33.CSOs shall not participate, directly or indirectly, or give grounds to reasonably construe support, opposition or dislike of any candidate contesting the bye-election.

## **Midhey Gothrips**

34.An Elected Local Government functionary shall not participate directly or indirectly except to cast his /her vote in the bye-election.

#### (K) Postal Ballots

35.A person who applied for postal ballot shall not be allowed to vote in person as his/her name will be included in the postal voters' list and marked as 'PB" in the voters' list sent to the polling station by the Returning Officer.

#### (L) Electronic Voting Machine (EVM)

36. The Electronic Voting Machine (EVM) shall be used for polling in all the *Demkhongs*.

#### (M) Indelible Ink

37. Indelible ink shall be used during the bye-election and marked from top of the nail to the bottom of the first joint of the RIGHT index finger.

#### (N) Poll Day

- 38. The poll day for the bye-election shall be on 3<sup>rd</sup> February, 2022.
- 39. The poll day shall be declared as a public holiday in the Khamdang\_Ramjar *Demkhong*.
- 40. The ECB shall accept either the Citizenship Identity Card (CID) or Voter Photo Identity Card (VPIC), in original, for the purpose of identification of the voter on the poll day.
- 41.All employers are required, by law, to grant the required number of days as leave of absence for a reasonable period as is necessary to enable him/her to vote at the election, subject to the exceptions made in Sections 339 and 341. However, due to COVID-19 pandemic, all voters residing outside the demkhong are encouraged to register and vote through postal ballots.

#### (O) Election Result Counting, Consolidation and Declaration

- 42. After the close of polls, the polling stations shall become the Counting Centres where the EVM results shall be counted immediately, as per the set procedure, and relayed to the Returning Officer and the ECB Headquarter.
- 43. Candidates or their representatives can witness and observe all stages of the polling and counting procedures but shall not make public statements on estimates and guesses before the results of election are officially declared.

#### (P) Election Officials

#### **Election Coordinators**

44. The Dzongdag shall be appointed as the Chief Election Coordinator; Dzongrab as the Deputy Chief Election Coordinator; and the concerned Gewog Administrative Officers as the Gewog Election Coordinator responsible for carrying out the roles, responsibilities and duties as provided in the Electoral Laws and Appointment Order issued by the Election Commission of Bhutan for the conduct of the bye-election.

#### **National Observer**

45. The Election Commission shall depute senior officer from the Civil Service as National Observer in the *Demkhong*, vested with the authority, roles, and responsibilities as per the provisions in the Electoral Laws, Rules, Regulations and in particular the relevant provisions contained in the Guidelines for National and International Observers and the Appointment Order.

#### **Returning Officer**

46. The Election Commission shall appoint Returning Officer vested with full authority, roles and responsibilities as per the provisions in the Electoral

Laws, Rules, Regulations and Handbook for Returning Officers and the Appointment Order.

#### **Presiding and Polling Officers**

- 47.Returning Officer shall appoint the Presiding and Polling Officers from the list of government officials working in the same Dzongkhag, provided by Dzongkhag Election Office.
- 48.Presiding and Polling Officers are vested with the authority, roles and responsibilities as per the provisions in the Electoral laws, Rules, Regulations and Handbook for Presiding Officers.

#### **Counting Supervisors & Counting Assistants**

- 49. The Returning Officers shall authorize the Presiding Officer and Polling Officer III in a polling station to function as the Counting Supervisor and the Counting Assistant to count the results after the close of Poll.
- 50. Counting Supervisors and Counting Assistants shall be vested with the authority, roles and responsibilities as per the provisions in the Electoral Laws, Rules, Regulations and Handbook for Counting Supervisor and Counting Assistant.

#### **Media Arbitrator**

51. The Media Arbitrator appointed for the bye-election shall be vested with the authority and be responsible for fulfilling the roles and responsibilities as provided in the Electoral Laws, Rules, Regulations, and the Appointment Order.

#### **Assignment of Duty Stations**

52. National Observers, Returning Officers, Presiding Officers, Polling Officers, Counting Supervisors and Counting Assistants shall ensure that he/she is not being placed in the Dzongkhag where his/her *Gung* or *Mitsi* is registered, unless authorized otherwise.

#### (Q) Election Control Rooms

53. For the purpose of monitoring, supervision and direction of the conduct of election, election Control Rooms shall be set up in the Office of the Returning Officers at the *Demkhong* level and at the Election Commission headquarters for the national level.

#### (R) Uncontested Election

- 54.If there is no Candidate after the last date for filing of nomination of Candidates notified herein, the election will be postponed till further notice.
- 55. The *Demkhong* with only one candidate after the last date of filing of nomination of Candidates announced herein will be conducted as 'Uncontested Election' in accordance with Sections 575 and 576 of the Election Act of the Kingdom of Bhutan, 2008.

#### (S) Law and Order & Deployment of Forces

- 56. The Royal Bhutan Police shall be responsible for deploying security personnel at every polling station as per the *Election Security Rules and Regulations of the Kingdom of Bhutan*, 2012.
- 57. Security personnel shall ensure that he/she is not being placed in the Dzongkhag where his/her *Gung* or *Mitsi* is registered, unless authorized otherwise.
- 58. The Election Security Focal Officers shall work in close coordination and cooperation with the election officers as a team towards conducting the election smoothly.
- 59.Desuups shall be mobilized as per requirements to supplement and complement the efforts of the RBP and to enforce the COVID-19 health safety protocols.

#### (T) Election Dispute Settlement System

60.The Central Election Dispute Settlement Body (CEDSB) and the Dzongkhag Election Dispute Settlement Body (DEDSB) shall be appointed for the bye-election for adjudication of election disputes in accordance with the Electoral Laws, the Election Dispute Settlement Rules and Regulations and the Election Dispute Settlement Manual.

61.Election Disputes may be filed with a Returning Officer, National Observer, Chief Election Coordinator, or the Chief Election Commissioner but must contain all details as in Election Complaint Form.

Now, thereof, from the day of issue of this Notification, the Election Commission of Bhutan notifies the general public on the election schedule of the bye-election and all matters relating to it.
