1. Phuentshogling

Of the **1168** registered eligible voters (M= 570 & F= 598), 583 (EVM:549 & Postal Ballot:34) cast their votes on the poll day with voter turnout at **49.91%**.

2. Thimphu

Of the **9202** registered eligible voters (M= 4271 & F= 4931), 2935 (EVM: 2877 & Postal Ballot: 58) cast their votes on the poll day with voter turnout at **31.90%**.

In terms of the overall voter turnout of the two *Dzongkhag Thomde Tshogde* Elections, 2026, of the **10370** registered eligible voters (M= 4841 & F= 5529), 3518 (EVM: 3426 & Postal Ballot: 92) cast their votes on the poll day with overall voter turnout at **33.92%**.
